**RATES APPLICABLE:****Motiva Refinery Incentive Rate Terms:**

1. The incentive rate set forth in this tariff applies to shipments of any shipper contracting for transportation of a minimum guaranteed volume of 6,000,000 barrels per month.
2. Should shipper fail to ship the minimum guaranteed volume during any month then Shipper shall have the obligation to ship the deficient volumes (minimum guaranteed volumes less actual volumes shipped) during the immediate following month plus the minimum guaranteed volume.

**Total Petrochemicals Refinery Incentive Rate Terms:**

1. The incentive rate set forth in this tariff applies to shipments of any shipper contracting for transportation of a minimum guaranteed volume greater than 100,000 barrels per day per month.
2. Should shipper fail to ship the minimum guaranteed volume during any month then Shipper shall have the obligation to ship the deficient volumes (minimum guaranteed volumes less actual volumes shipped) during the immediate following month plus the minimum guaranteed volume.

**GATHERING RATE:** The rates named herein are for trunk line transportation only and no gathering service will be performed under this tariff.

**Exception to Item 40, F.E.R.C. No. 3.0.0, Measurement, Testing, Volume Correction and Deductions – Crude Petroleum:** No deduction will be made to cover evaporation, interface losses or other normal losses during transportation.

**Exception to Item 65 F.E.R.C. No. 3.0.0, Proration of Pipeline Capacity:** The “ETP Crude LLC Proration Policy PANS Pipeline” effective April 1, 2023 will be provided upon request by the person listed as “compiler” on the title page of this tariff, and may be updated at any time to comply with applicable law or as may be necessary to comply with upstream or downstream connecting carrier requirements or its own operational requirements.
